- 1) for the collection and processing of my personal data, including: surname, first name, patronymic (if any), year, month, date, and place of birth, nationality, individual identification number, identity document details, information about the place of residence, registration address, postal and email address, telephone number, biometric, financial, and confidential information (hereinafter referred to as the Information), necessary and sufficient for the Bank to fulfill its tasks and provide banking and/or other services, any actions within the laws of the Republic of Kazakhstan and this Consent Statement, with my Information, including actions to obtain, systematize, accumulate, store, confirm, update, modify, use, distribute, de-identify, view, block, and destroy the Information, transfer of Information to a credit bureau, obtaining Information by the Bank from a State database(s) (hereinafter referred to as the SDB), and/or any other objects of informatization, including through a credit bureau, SDB service, operators/owners of SDB, as well as disclosure and transfer in scope and order, of information available to the Bank, including Information and/or banking secrecy, to third parties (including cross-border transfer) and members of the VTB Group. Also, I give my consent for the credit bureau to provide the Bank with the Information from the SDB, for the credit bureau, the Bank to obtain the Information from the SDB from the operators/owners of SDB, to provide Information from all SDB to credit bureaus and the Bank by operators/owners of SDB directly and/or through third parties, as well as for the person authorized by the Government of the Republic of Kazakhstan to provide public services to provide the Information to the credit bureau and the Bank through the credit bureau, including in the future. I hereby confirm receipt of the consent of third parties, information about whom I provide to the Bank in any form, to the transfer of their personal data to the Bank and to their further processing and storage in accordance with the specified, and I assume the obligation to notify such persons about it;
- 2) for providing the Bank with information about me to the credit bureaus in accordance with the provisions of Article 23 of the Law of the Republic of Kazakhstan *On Credit Bureaus and Formation of Credit Histories in the Republic of Kazakhstan*;
- 3) to issue a credit report about me to the Bank by the credit bureaus, including information from the State database(s), including data that will be available in the future;
- 4) for provision of information to credit bureaus about me by the organization carrying out activities related to collection and provision of information on income of individuals to credit bureaus (hereinafter referred to as the Organization)/ for the credit bureaus to provide the Bank with credit reports with information obtained from the Organization, and for the Bank to receive a credit report with information obtained by the credit bureaus from the Organization in accordance with the laws of the Republic of Kazakhstan;
- 5) for accessing information/obtaining information about all signed electronic documents between the Bank and me, and/or other related to the mentioned documents/my information from the certification center, including related to the confirmation of my EDS/certificates on my EDS;
- 6) for taking a picture (still picture) and/or sound and/or video recording as well as for collecting / confirming / updating / storing / using / copying / transmitting and reproducing, including in the presence of third parties of my image (picture / video with sound / without sound) and/or voice message(s).

This Consent Statement applies to existing Information and to information that will be received by the Bank in the future.

This Consent Statement shall be valid until the expiry of the retention period of the files/documents, consents in accordance with the requirements of the laws of the Republic of Kazakhstan, as well as the laws of foreign countries affecting the activities of the Bank.
